The Council of the City of Mountain Home, Elmore County, Idaho, met at the Mountain Home City Hall Chambers, 160 South 3rd East, Mountain Home, Idaho on June 8th, 2020. A quorum was established with, Councilman Stokes, Councilman McCain, Councilman Bundy, Councilman Brennan and Mayor Sykes being present.

RECOGNIZING PERSONS IN THE AUDIENCE

No one came forward to speak at this time.

Republic Services Update - Rachele Klein, Business Manager

Rachele Klein spoke about Republic Services in Mountain Home, the services they provide and the cost of the services to the company.

COUNCIL COMMENTS

• Fire Chief, Mark Moore said they will have their first full training since the shutdown from Coronavirus this Thursday. He said the reprogramming at Rattlesnake Butte is underway and they will be working on the frequency switchover this week. DEQ is still requesting people not burn.

• William Lamb, Library Director said during their downtime they painted the Library and they are trying to work on programming currently since it will have to be drastically different this year because of recommended social distancing.

• Police Chief, Scott Conner said they have four new Dodge Durango police vehicles they have taken possession of for the supervisors. He said they are working with Allied on some programming issues at the Police Department.

• Tiffany Belt, Recreation Superintendent said they are having swim lessons at the pool and they are hoping to open for public swim the 29th of June, possibly sooner. She said participation numbers are growing.

• Miguel Pedroza, Parks Superintendent said Free Fishing Day is this Saturday and they are staying busy mowing the parks.

• Gene Palmer, Street Superintendent said the street sweepers are running as much as possible. He said they put new pedestrian lights up by Taco John's on Main Street.

• Dave Sonnentag, Water Superintendent said the wells are running fine and now they are working on the SCADA system.

• Jake Olsen, Golf Course Superintendent said he is just working to maintain the course.

• Shirley Batchelor, Wastewater Superintendent said they finished the first harvest at the farm and they are doing a lot of cleaning and running the camera through the sewer system.

• Hank Patrick, Building Official said they have issued a lot of building permits with the warm weather. He said Hubble Homes is still building but CBH Homes is waiting for new streets to be finished before they can move forward.

• Courtney Lewis, Economic Development Director said last week they held a zoom call for Downtown Public Outreach and since there is a recording they will be putting it out on social media, for anyone who wanted to view it. She said they have gotten their rail assessment back and they will be going over that this week. There has been some interest from companies in the rail. something start to develop there in the next 60 days. Family Fun Zone has opened and the brewery that has been announced has closed on the property they bought so they should be working toward opening. She said her last day will be the 26th of June and there will be a week of overlap with the new Community Development Director before she leaves for her new job.

- Rich Urquidi said there was more water pumped this May than usual, possibly because everyone was still at home and it was a little warmer than normal.

- Karl Vaughn was present from ITD to discuss the left hand turn from Walmart on to American Legion.

- Councilman Brennan thanked the City Police Officers for their service.

- Councilman Stokes said the Pollinators Proclamation was this morning. He thanked Josh Dison for calling him over the weekend about a leak at the skate park. He said the Coronavirus numbers have gone up to 32 so there was an increase of one. He said he has reached out to the Lions Club and the Arts Council to help with labor for the band stand that was approved for Carl Miller Park.

OLD BUSINESS

Discussion/Decision on the City continuing to offer the Hazardous Waste Collection Day and proposal received from Stericycle Environmental Solutions. ACTION ITEM.

Mayor Sykes said he attended the Commissioners meeting last Friday and spoke with them about a partnership between the City and the County for Hazardous Waste Collection and they said there was no need to do that as they already offer disposal for Hazardous Waste through the County landfill. There is a pesticide disposal program through ISDA.

Tiffany Belt, Recreation Superintendent said she had reached out to Deb Ireland who runs the County Landfill to go over what they would accept out there. She said her department will still partner with US Ecology to do a Hazardous Waste Day for the City to drop of waste at no cost to the City.

It was decided there was no need for the City to take any action at this time to offer Hazardous Waste Collection since Elmore County provides the service. The City would still partner with US Ecology to offer a Hazardous Waste Day Collection out of the Parks and Recreation Building for as long as US Ecology was willing to sponsor it and continue to do it at no cost to the City.

NEW BUSINESS

Councilman Brennan said as he was reading through this he saw there was no City cash match required but then as he continued reading there was a match from the CARES money that was given to the city. He asked if the City had paid all the hazard pay and all of the bills from COVID that had come in so far.

Nina Patterson, City Clerk said she does not have all the numbers but so far there is \$136,000.00 worth of reimbursement for payroll and supplies, she said there would still be a few bills more to be reimbursed because City Hall was putting in a permanent glass counter but as of right now that was what has been used.

Councilman Brennan said there should be approximately \$361,000.00 left over.

Nina said that was correct.

Councilman Brennan asked if it could be used on lost revenue.

Paula Szafranski, City Treasurer said they asked about that and it was not allowed to be used that way.

Councilman Brennan asked if this was an approved way to use the CARES money.

Courtney Lewis, Economic Development Director said yes, as long as it is tied into telehealth and telecommuting or education it could be used for fiber.

There was a discussion on where they would run the fiber backbone.

Mayor Sykes said they would try to fit in as much as they could but the project had to be completed by December 31st, 2020.

Councilman Bundy made a motion to approve the grant application approval request for Grant #2019/2020-017 for an Idaho Broadband Project for the CARES ACT Grant Funds through the State of Idaho to complete the installation of the City Fiber Optic Backbone and Authorize the Grant Administrator to apply for the Grant. Councilman Stokes seconded the motion.


