A quorum was established with, Councilman Green, Councilman Brennan, Councilwoman Garvey, Councilman Bundy and Mayor Sykes being present.

### DEPARTMENT HEAD COMMENTS/REPORTS

- Gene Palmer, Street Superintendent said they are painting and doing maintenance.
- Jon Thompson, Police Chief said Patriot Thunder would be in town about 12:30 p.m. on Sunday.
- Dennis Pings, Recreation Superintendent said they are about half way through their summer programming.
- Brock Cherry, Community Development Director said residential home permits are starting to come in at a pretty good pace.
- Shasta Hochstrasser, Library Director said the Summer Reading Program just ended and 600 participants read for over 2800 hours. The Family Night the Library hosted was a great success. She said hopefully by August the privacy pod for the Library would be under construction.
- ullet Rich Urquidi, Director of Public Works said they are working on  $14^{\mathrm{th}}$ street and getting the project in that area complete. At the RV dump site they are replacing the trash cans at the site, with smaller trash cans. He said they are hoping to start West 5th paving before the end of July.

Councilwoman Garvey said she would like on the record for it to be stated the city will not be taking anyone's property to do this project.

Rich Urquidi, Director of Public Works said the city didn't see where they would need to take any further right-of-way on the North side of the road. He said for this project that wouldn't be necessary.

Councilman Brennan asked at what phase of this project would both points of access be available.

The developer said in the first phase there would be two points of access.

Councilman Green gave a presentation on his findings for the number of non-residents using the Recreation Programs.

Councilman Bundy said there also needed to be the cost of the program for every participant added in. He said there is also something to be said about being a good neighbor to our base and county residents.

Councilman Brennan said the email he and other Council members received suggested opening the programs for a few days to City residents before opening it to others may be a good place to start.

Councilman Green said he would continue to do research and bring further information back to the Council.

3)Action Item: Deliberation/Decision on Imagine Venture's request for a letter of support regarding an Elmore County tax exemption. (Item continued from June 27, 2023)

Councilman Brennan said he was willing to waive the impact fees until time of occupancy so Mountain Home could introduce this kind of development. He does not feel if they can be fully functional within two years then they need a five year property tax exemption. He said if this request is approved by the County Commissioners it will be the first of its kind in the state of Idaho. He said ultimately he doesn't feel he can support this letter to Elmore County. He also stated he would like to have his opinion completely spelled out to the Commissioners, not just having it written the majority of the Council approves this tax exemption.

Councilman Bundy said he feels they all share Councilman Brennan's feelings. He said they could form a letter stating support for the project and strike the language of the tax exemption from the letter.

Councilwoman Garvey said she also shared those same feelings, but understood the investors for Golf View apartments also needed a certain rate of return for the project and she supports the developers and the project. She said she wouldn't mind striking the language of supporting the tax exemption.

Councilman Brennan made a motion to deny the tax exemption.

Councilman Bundy said point of order, the denial of a motion was not on the agenda.

There was no second to the motion and it died.

Councilwoman Garvey said it isn't the city's place to deny a tax exemption or approve it. Only the County can approve or deny the request. She said she supports the project.

Councilwoman Garvey made a motion to approve the letter as written to go to the County Commissioners. Councilman Bundy seconded the motion.

Councilman Brennan said even if the intent is correct the letter would need some work before being sent.

Councilwoman Garvey amended her motion to say she supports the language of this draft letter to be sent with correction of grammatical errors.

Councilman Brennan said the letter also doesn't state in its current form the length of the tax exemption the city supports or the percentage of the exemption.

Councilwoman Garvey said she supports five years at eighty-five percent.

2) Action Item: Deliberation/Decision on Planning and Zoning Commission for recommendation and finding of facts to approve rezone R-4 PUD entitled "Freer Field R-4 PUD" with conditions. (Staff report provided via email on June 14, 2023)

Councilwoman Garvey said the vacation needed to be done before the rezone.

Paul Fitzer, City Attorney said the order the items were set in tonight were fine.

Councilman Brennan said these were two story units. He asked Fire Chief Moore about the setbacks of the property, he said it was three feet on each side for a total of six feet. He asked if there was a fence down the middle of these two story units would it be possible to get an extension ladder down the middle with a fence in place.

Chief Moore said it has met the minimum standards through fire code. Though it wasn't ideal circumstances.

Councilman Brennan said he disagrees with the three-foot setbacks. He said city ordinance is five feet. He said the other thing he was conflicted about was the gravel parking area. If the lot is too dense that you cannot contain your own stormwater, then there is an issue. Councilman Brennan said on PUD page nine it identifies there is a duplex on three lots and he thinks that is a typo.

Terran Mitchell, Site Designer said building code says buildings can be within five feet of each other without any issue. He said a compromise would be that there is no fence allowed between the buildings, though he was unsure if that were better for the residents.

Councilman Brennan said he doesn't think if the units are rentals the no fence stance made sense but if the units were being sold he doesn't agree with telling them where they can or cannot have a fence. Though he isn't sure this is safe.

Terran said the building code has been refined for decades and if there was an issue it most likely would have been addressed. As designed this meets or exceeds those codes.

Councilman Brennan asked why the applicant requested to use gravel and not pavement.

Terran said the more asphalt there is the more roads you pave the hotter everything is. He said this will help with heat effect and stormwater drainage and retention. Long term he feels it would be better and create a working creative solution.

Councilman Brennan asked if there is a way to slope the driveways for stormwater drainage.

Terran said absolutely, they were looking at new solutions, the goal isn't to have a lot of unpaved parking spots sitting empty and creating heat.

Councilman Bundy said his concern with this is creating a precedent. Council Minutes - July  $11^{\rm th}$ , 2023

Councilman Green said he was wondering if the building could be moved a couple of feet to the side to create more space.

Terran said he believes there is an extra foot or two that way. He said he gives himself a foot buffer from code.

Brock Cherry, Community Development Director said this has been viewed by professionals and deemed to be safe according to International Building Code.

Councilman Brennan said he would like to see a five foot setback on each side for a total of ten feet.

Councilman Green made a motion to approve the R-4 PUD entitled "Freer Filed R-4 PUD" with conditions. Councilwoman Garvey seconded the motion.

Brock Cherry, Community Development Director said it was not. The PUD had been approved and the plat has to meet whatever is set in the PUD.

Councilman Brennan said he would like to send this back to P&Z to work out the parking and setbacks.

Terran Mitchell said if there is issue with the gravel, they can look Council Minutes - July  $11^{\rm th}$ , 2023

into grass to absorb the stormwater. Though he does feel this project being on the smaller side would be a good project to start this with.

Councilwoman Garvey said her concern was with weeds growing up in the gravel.

Councilman Brennan made a motion to send this item back to P&Z to reexamine, widening the interior setbacks and to look at the parking situation. Councilman Green seconded the motion.

Councilwoman Garvey asked if there was the potential to table this and let the council bring this back at a later date instead of sending it back to Planning and Zoning.

Paul Fitzer, City Attorney said that was correct.

Councilman Brennan asked if that would be a material change.

Paul said it did not amount to one.

Councilman Bundy said if we could do a motion to pass this with the parking being up to code, then this seems solved according to city code.

Members of the Mellen Water District Board were present to discuss the lease.

Erica Pedroza from the Mellen Board said she apologized they didn't get the letters informing them the lease was ending, so they weren't sure where to go from here but they wanted to address the council and seek guidance on who they should speak to on this matter.

Mayor Sykes said it is difficult because the city wants to be a good neighbor and wants to make sure no one goes without water.

Councilman Brennan asked if the board was able to obtain any information about water rights.

Erica said they haven't so far but are trying to get the information and plan on sharing it with the city as soon as possible. The issue is sand and sediment getting into the pump and causing it to break down.

Paul Fitzer, City Attorney said without an agreement the Mellen Water Council Minutes - July  $11^{\rm th}$ , 2023

District cannot be a customer, they are just in limbo but also putting strain on the city water system.

Councilman Brennan said whatever the action taken is it will be extremely expensive. He said he hoped they are ready for the cost that will be incurred.

Erica said she needs to find funding information and would appreciate any help the city could give.

Paul said there was no way for the lease to move forward the way it is. He asked if the Council wants to have the district explore the option of joining the city or explore continuing the district as is and rewriting the lease.

Councilman Green said he was in favor of tabling, so the district had more time to figure out their options.

Tiffany Belt, City Clerk asked that it be tabled until August  $8^{\mathrm{th}}$  to allow Mellen and City staff more time to work this out.

Councilman Brennan said he was amenable to extending this to August  $8^{\mathrm{th}}$ , but he would like to see the district come back to the city within two weeks after the 8th with a decision on the direction the district would like to go.

Councilman Green made a motion to table this item until the August  $8^{\rm th}$ , 2023, meeting. Councilman Bundy seconded the motion.
