The Council of the City of Mountain Home, Elmore County, Idaho, met at Mountain Home City Hall, 160 South 3rd East, Mountain Home, Idaho on July 7th, 2020. A quorum was established with, Councilman McCain, Councilman Stokes, Councilman Bundy and Mayor Sykes being present at 3:00 P.M. Councilman Brennan was absent as he was responding to a fatal crash for the Idaho State Police Department.

Discussion/Decision To Allow the Grant Administrator to proceed with the Grant Application for the Idaho Broadband Project for CARES ACT Grant Funds through the State of Idaho - Grant #2019/20-017. ACTION ITEM.

Councilman Bundy said it was his understanding that this was money the City was planning to spend on the project anyway so putting in for this grant might help the City recoup some of the money.

Mayor Sykes said Councilman Brennan had expressed concern about the verbiage on the grant by the state. He said he did not like where the grant stated the City may be reimbursed, not that the City would be reimbursed.

Councilman McCain said the language from the state on the grant was concerning to him as well.

Councilman Bundy said he didn't like the language either, however, this was money the City would be spending on the project anyway so if there is a chance part of the project would be reimbursed through the state, then it didn't hurt to put in for the grant.

Councilman Stokes made a motion to allow the grant administrator to proceed with the grant application for the Idaho Broadband Project for CARES ACT Grant Fund through the State of Idaho - Grant #2019/20-017. Councilman Bundy seconded the motion.


The majority of the vote being in favor, the motion was carried and so ordered.
