The Council of the City of Mountain Home, Elmore County, Idaho, met at the Mountain Home City Hall Chambers, 160 South 3rd East, Mountain Home, Idaho on January 24th, 2022. A quorum was established with, Councilman Stokes, Councilman Brennan, Councilman McCain, Councilwoman Garvey and Mayor Sykes being present.

Tiffany Belt, City Clerk said they have had a hard time getting a quorum in the last year and the consensus was it was best to put them on hiatus, so citizens would not show up to the meetings only to find out they had been canceled.

Tiffany asked if an Item M could be added to the Consent Agenda because the grant application is due by Friday and would require the Mayor's signature.

Item H: Approve resolution to be prepared for a wastewater rate increase from \$25.70, the base rate for the $1^{\rm st}$ 5,000 gallons, to \$26.95 and from \$5.40 per 1,000 gallons over the 5,000 gallons to \$5.65 to be effective as of March 1, 2022.

Councilman Stokes asked to discuss both Items H and I at the same time. He said he struggled with this because while inflation is high, if the City has the money this year for a new well then there should be no issues with money, without raising the rates.

Councilman Brennan felt since there is going to be a discussion about EDUs, he would rather have that discussion before the Council votes on a raise to Water and Wastewater.

Councilwoman Garvey asked what specific projects public works is trying to fund with the raise to the rates.

Public Works Director, Rich Urquidi said he felt the estimates for the well would go over what they had budgeted for, and this year they would have construction of the College Park Subdivision water system. He said in the next budget cycle the Tindall subdivision would go through the same construction process.

Councilman Brennan said in his mind the EDU process should be decided before they have a discussion on the Water and Wastewater rates.

Tiffany Belt, City Clerk said it is important to always loop in the wastewater and the other thing she wanted to bring up is the change to EDUs will need to be a change in the code book and that process takes time to go into effect and waiting until the EDU discussions take place will mean pushing the rate increases potentially into the summer months.

Councilman Stokes said the City is due for another installment of ARPA funding and he would like to use those funds for Water and Wastewater projects and not raise the rates.

Councilwoman Garvey asked if it was possible to wait until the budget cycle is over to decide on the rate increase.

Paula Szafranski, City Treasurer said the budget wouldn't be finalized until June and then you are already into the summer months.

Councilman Brennan said while they saw the rate increase coming, the Council isn't aware of how much more money the increase will bring into the City for projects. He said he thinks the Council can work through the EDU process in the matter of a couple of months, though it may take some extra meetings.

Councilman Stokes asked how often the city goes through and calculates EDUs for businesses and homes.

Mayor Sykes said the city is supposed to go in at least every third year to evaluate the EDUs in businesses but currently there is not the staff for that.

Councilman Brennan said if there were a required business license, even if they were free to obtain, then there would be a better accounting of what kind of businesses and how much water the type of business used.

Paula said the usage to the allocation of EDUs is on target for most customers. She said her concern is the wastewater, she does not want to overbill customers on their wastewater.

Councilman Brennan made a motion to table items H and I until at least Council Minutes - January 24, 2022

the first EDU discussion had taken place. Councilman Stokes seconded the motion.

Discussion on roof replacement for City Hall.

Tiffany Belt, City Clerk said the discussion for the roof replacement has been going on for around twenty years, but recently the leaking has gotten substantially worse. She said she has gotten a couple of quotes at this point for both a flat and pitched roof but is seeking more quotes.

Councilman McCain said he has been working to get a roof for this building for the last five years and he feels it is needed.

The Council's consensus was to move forward getting bids to replace the roof on City Hall.

Councilman Stokes asked if the contingency funds from the last budget cycle had been used yet. He thought this would be a perfect use for the funds.

Paula Szafranski, City Treasurer said the contingency funds had not been used.

Councilman McCain made a motion for the Mayor and City Clerk to proceed with getting estimates for a pitched and flat roof. Councilwoman Garvey seconded the motion.

Councilman Brennan asked if the City could go out for a full public bid through newspaper posting since there are so many contractors that do roofing. He said he would like to see it advertised at least once to see the variation of price we may get. He said he didn't know how many times it would need to be posted but at least one announcement for a bid in the paper, for any qualified bidder.

Councilwoman Garvey asked if the reason item line four was put in was because there is currently someone on the commission who lives outside the area of impact.

Brock Cherry, Community Development Director said that was correct, but looking at other cities it is fairly common to see, because they recognize that we are not just a city but a region as well and having a county member outside the area of impact gives the commission that perspective.

Councilwoman Garvey asked if having someone who lived in the delimited area goes against state code if it states you need to have someone living in the area of impact.

Paul Fitzer, City Attorney said no, as long as one member lives in the area of impact, we are going along with state code.

FINAL COMMENTS

- Rich Urquidi, Director of Public Works said he is trying to get everything together to hopefully go out for a new traffic study.
- Shasta Hochstrasser, Library Director said this week they have Winter Adult Reading Bingo on Saturday, and next week they will be doing a How Money Works Workshop along with an Adult Craft Night and Book of the Month Club.
- Shirley Batchelor, Wastewater Supervisor said they are keeping a close eye on the sewer lagoons levels, which are currently below what they were last year. So they are making sure they are putting water in the right places.
- Police Chief, Scott Conner said they have one person currently in the academy and will be doing testing for new officers this Saturday.
- Brock Cherry, Community Development Director said they have had a substantial commercial user looking at Mountain Home and they will be building a tire warehouse that will supply around sixty jobs initially, and the next phase will be a Love's Truck Stop. They would like to start building this summer. He said they will have to be annexed and zoned before moving forward. Brock said there are no build to suit home in Mountain Home, CBH has run out of homes to sell, and they are hoping some of the newly approved developments will help with the shortage in houses.

Councilman Stokes said when he talks to constituents a lot of them are scared of growth. He said he would like to see Economic Development host an Open House about housing and businesses. He would like to see them partner with Public Works to discuss water and EDUs.

Brock said that was something they could do. He noted there is a plan for affordable housing with LEAP Charities.

- Tiffany Belt, City Clerk thanked the Council for approving Item M on the Consent Agenda and said she felt it would be helpful for the Council to participate in the Open Houses the City will be hosting.
- \bullet Councilman McCain said they cannot take every citizen suggestion that is brought forward, but they do use them as guides in their decision-making process.
- ullet Councilman Stokes thanked everyone for coming to speak. He said after consulting with Jim McNall at ICRMP he wrote an ordinance that would allow Councilmembers to add items to the agenda as they see fit. He said he would like to see this on the February 14th agenda.
- Councilman Brennan said he attended an Airport Committee Meeting. He said he had a lot of questions for the group. He said he felt the reader board downtown is being inappropriately used. Next, he would like to see the City amend its Covid policy to reflect CDC guidelines.

Tiffany said they have been looking at the guidelines and making some changes but wanted to make sure the guidelines will be that way for a little while.

- Councilman Brennan said it is hard to sit at the front of the room and not let the audience talk, but as soon as there is a two-way conversation the order leaves the room. He said affordable housing has been addressed, but they cannot deny developers meeting the ordinances as they are written, simply because they are not building affordable housing. He said the Impact Fees are coming but we do not know at what rate yet. Councilman Brennan said he reads every email and declares it in the appropriate place on the agenda. He said he fully supports the idea of a townhall meeting. He said with the new development for a warehouse coming they need to make plans on connecting Hotcreek Rd and Foothills Rd.
- Mayor Sykes said it isn't that the council doesn't want to engage with people but during a public meeting is not the time. He invited everyone who had questions to email him, and he would be sure to reach out.
