The Council of the City of Mountain Home, Elmore County, Idaho, met at the Mountain Home City Hall Chambers, 160 South 3rd East, Mountain Home, Idaho on April 27th, 2020. A quorum was established with, Councilman Stokes, Councilman McCain, Councilman Bundy, Councilman Brennan and Mayor Sykes being present.

RECOGNIZING PERSONS IN THE AUDIENCE

- Jeff App, who owns The Edge Bar was present and discussed the need to reopen his establishment and his plan to keep employees and staff safe when he reopens during the Coronavirus Pandemic. He said he disagrees with the phase four plan laid out by Governor Little.
- Mark Bryant, owner of Mark Anthony's Bar was present to discuss reopening of his bar which has been closed because of the pandemic.
- Mary Velasco came before the Council to state she was starting a petition to recall Mayor Sykes.

COUNCIL COMMENTS

Councilman Stokes said he has been watching the coronavirus numbers and he feels Elmore County has done a good job flattening the curve. He is looking forward to participating in the Mountain Home High School Prom Cruise they have planned for Saturday.

Councilman Bundy thanked the business owners who came to speak with the council, and he knows how badly everyone wants to get back to work in the safest way possible.

Councilman McCain said he has stated before he would like to see the bar owners move from phase 4 to phase 3 of the state reopening plan. He said he is concerned about controlling people who have been drinking. He isn't sure they can maintain social distancing.

Councilman Brennan said he is ready to reopen the economy on May 1st.

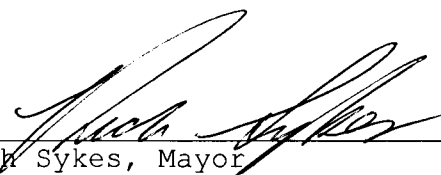
There were no items removed from the Consent Agenda.
