Brock Cherry, Community Development Director explained the location of the property requesting sewer services.

Councilman Brennan said he did not feel the application should be before the Council because the property is contiguous and able to be annexed by the city, so there is no reason they shouldn't be if they want to benefit from city services.

Councilman Brennan made a motion to deny the contract for sewer services outside the city. Councilman Green seconded the motion.

Rich Urquidi, Director of Public Works said this is before the Council because United Metals is going to put in sewer line for the city and to do so they must take the line across other properties, some of which aren't annexed. He said United Metals asked all the properties for an easement to run the sewer line through those properties. Once the line has gone through the property in question it will leave no room for a septic tank in that location. Rich said if this is denied United Metals will most likely have to put in a septic tank of their own because they will be more than 200 ft. from city services and ordinance states that over 200 ft. from city services a property may have a septic system within city limits.
